## **DECISION**

- 1. Due to the current epidemiological situation regarding COVID-19, all employees who have resided outside the Republic of Croatia in the past 14 days must contact the heads and coordinators of organizational units (Administration of the Faculty) and remain in self-isolation. During that time, they are obligated to work from home (a total of 14 days from the return).
  In case the symptoms occur during self-isolation, you are obligated to report to the epidemiologist according to the guidelines of the Croatian Institute for Public Health:
- 2. All students who have resided outside the Republic of Croatia for the past 14 days are obligated to contact the Vice Dean for Teaching (ivana.maric@medri.uniri.hr) and to remain in self-isolation (a total of 14 days from the return).

- Absence from classes will be excused and approved by Decisions from the Dean of the Faculty.
- 5. Classes at postgraduate university studies (doctoral studies and postgraduate professional studies), as well as enrollment in the doctoral school, shall be deferred for 30 days from the date of making this Decision.
- 6. Classes in which students have a direct contact with the patient are replaced by a seminar method of teaching (if possible) or postponed for 14 days from the date of signing this Decision.
- 7. Business trips to high-risk areas within 14 days will not be authorized.
- 8. Communication with all administrative and professional services within 14 days from the date of making this Decision shall be carried out electronically.
